

PUBLIC OFFER

1. TERMS AND DEFINITIONS

Organizer (We): LCC, RADIO NETWORK TELEKOMMUNICATIONS EQUIPMENT TRADING LCC, address: AI DAYAR, AI WASL, 646-0, OFFICE 3-188, Dubai U.A.E, INN 7705099961, PSRN/PSRNSP 1037739170270, contact e-mail: worldtacticalsports@gmail.com

Tournament: The competitive event titled "World Tactical Sports," conducted by the Organizer from "16/12/2026" to "21/12/2026" on the ARENA platform/game, the detailed rules of which are set forth in Section 4 of this Offer and the Tournament Regulations.

Participant (You): A legally capable natural person or team captain acting on behalf of the team, who has accepted the terms of this Offer and has completed registration to participate in the Tournament.

Prize Fund: Monetary funds and/or material valuables intended for distribution among the Winners and Prize-winners of the Tournament in accordance with Section 5.

Regulations: A document describing in detail the rules, format, schedule, technical requirements, and other conditions for holding the Tournament. The Regulations are an integral part of this Offer.

Acceptance of the Offer: The Participant's full and unconditional acceptance of the terms of this Offer by performing conclusive actions – registering for the Tournament on the website and confirming agreement to the terms.

2. SUBJECT OF THE OFFER

2.1. This Offer is the official and public proposal of the Organizer to conclude an agreement with any Participant regarding the organization and conduct of the Tournament on the terms set out below.

2.2. The Tournament is conducted in accordance with this Offer, the Regulations, and the rules of the game/platform from Inter Global Game company.

2.3. By accepting the Offer, the Participant confirms that they have fully read and agree with all the terms.

3. REGISTRATION AND PARTICIPATION PROCEDURE

3.1. To participate, you must:

- Have an active account on the platform.
- Complete registration on the website/platform during the period from 16/02/2026 to 16/06/2026.
- Fulfill all requirements specified in the Regulations (age restrictions, rating, etc.).

3.2. The Organizer has the right to refuse registration or remove a Participant from the Tournament at any stage in case of violation of the terms of the Offer, the Regulations, as well as for unsportsmanlike conduct.

4. TOURNAMENT RULES (REGULATIONS)

4.2. The Organizer reserves the right to make changes to the Regulations and schedule, notifying Participants through official communication channels (website, Discord server, etc.).

5. PRIZE FUND AND PAYMENT PROCEDURE

5.1. The total guaranteed prize fund of the Tournament is 1,000,000 USDT.

5.2. The dynamic part is formed from the funds received from the sale of tickets for participation in the qualifying stages on the ARENA platform.

5.3. Final prize pool: Upon the close of the registration period, the dynamic part of the prize pool is "frozen" and added to the guaranteed prize pool.

5.4. The resulting total forms the single final prize pool that will be awarded in the WTS final.

5.5. Distribution of the prize fund among the prize places:

5.6. Payment of the prize fund is made within 30 (thirty) calendar days after the end of the Tournament and the signing of the certificate of acceptance of services rendered.

5.7. To receive the payment, the Winner/Prize-winner must provide the Organizer with the necessary details and documents (completed questionnaire, copy of passport, taxpayer identification number, consent to data processing).

5.8. Financial payments are made to the cryptocurrency wallet of the participant from which the tournament participation fee was paid.

5.9. The Organizer has the right to change the size and structure of the prize fund with mandatory notification of the Participants before the start of the Tournament.

6. RIGHTS TO CONTENT AND INTELLECTUAL PROPERTY

6.1. Participants grant the Organizer a non-exclusive, free license to use their gaming and media content (nicknames, images, streams, video recordings of matches) created within the framework of the Tournament for the purposes of covering the event, advertising, and marketing by the Organizer.

6.2. All rights to the name, logo, design, and script of the Tournament belong to the Organizer.

7. LIMITATION OF LIABILITY

7.1. The Organizer is not responsible for failures in the operation of the Internet network, game servers, platforms, or Participants' equipment.

7.2. The Organizer is not responsible for the actions of third parties that may affect the course of the Tournament.

7.3. Participation in the Tournament is at the Participant's own risk.

8. DISPUTE RESOLUTION

8.1. All disputes are resolved through negotiations. If agreement is not reached, the dispute is submitted to the court at the location of the Organizer.

9. FINAL PROVISIONS

9.1. This Offer comes into force from the moment of its publication at _____ and is valid until the end of the Tournament and the payment of the entire prize fund.

9.2. The Organizer has the right to unilaterally change the terms of the Offer and the Regulations with mandatory publication of the changes. The changes do not have retroactive effect.
